OVER 3,100 FARMERS, STUDENTS, AND OTHERS ATTENDED THE 2.5 DAY EVENT. 67 WORKSHOPS WERE PUT ON BY 96 PRESENTERS, AND 181 EXHIBIT BOOTHS WERE DISPLAYED. THE ORGANIC RESEARCH FORUM HOSTED 11 WORKSHOPS AND 32 ORGANIC RESEARCH POSTERS WERE ON DISPLAY. TEN HALF-DAY LONG ORGANIC UNIVERSITY CLASSES WERE HELD WITH 740 PEOPLE ATTENDING.

WE ALSO ATTENDED DOZENS OF CONFERENCES AND TRADE SHOWS WHERE WE ANSWERED QUESTIONS AND DISTRIBUTED MATERIALS. OUR THREE ORGANIC SPECIALISTS ANSWERED OVER 800 QUESTIONS FROM NEW AND ESTABLISHED FARMERS ABOUT ISSUES RELEVANT TO THEIR SUCCESS.
