OVER 3,100 FARMERS, STUDENTS, AND OTHERS ATTENDED THE 2.5 DAY EVENT. 66 WORKSHOPS WERE PUT ON BY 102 PRESENTERS, AND 178 EXHIBIT BOOTHS WERE DISPLAYED. THE ORGANIC RESEARCH FORUM HOSTED 6 WORKSHOPS AND 17 ORGANIC RESEARCH POSTERS WERE ON DISPLAY. TEN HALF-DAY LONG ORGANIC UNIVERSITY CLASSES WERE HELD WITH 573 PEOPLE ATTENDING.
